ARTICLES OF INCORPORATION
OF A VIRGINIA NONSTOCK CORPORATION
DEEP RUN HIGH SCHOOL PTSO, INC.

The undersigned, pursuant to Chapter 10 of Title 13.1 of the Code of Virginia, states as follows:

1. The name of the corporation is Deep Run High School PTSO, Inc.
2. The period of duration is perpetual.
3. The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws). Specifically, the corporation is organized to support education of children at Deep Run High School by fostering relationships between the school, parents, students, and teachers. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under the Virginia Nonstock Corporations Act, whether or not related to the foregoing purposes, and to do all things necessary, proper, and consistent with maintaining tax-exempt status under 501(c)(3).
4. The corporation shall have one or more classes of members, the qualifications and rights of which, including voting rights, shall be designated in the Bylaws.
5. The directors/officers shall be elected by the Board members at a Board meeting on a future date.
6. The name of the corporation's initial registered agent is Pilar A. Moore, an individual who is a resident of Virginia and an initial director of the corporation.
7. The corporation's initial registered office address, which is identical to the business office of the initial registered agent is 12308 Bradford Landing Way, Glen Allen, VA 23059. The registered office is located in the county of Henrico.
8. The initial directors are:
 - a. Pilar A. Moore 12308 Bradford Landing Way, Glen Allen, VA 23059
 - b. Yvonne Terry-Kidney 12429 Gayton Station Boulevard, Henrico, VA 23233

9. The internal affairs of the corporation shall be regulated by its Board of Directors as described in the Bylaws. Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.
10. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles or of any Bylaws adopted thereunder, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
